SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 3). Flammable liquid and vapor (H226). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

Hazard class: Skin corrosion or irritation (Category 1). Causes severe skin burns and eye damage (H314).

Hazard class: Acute toxicity, inhalation (Category 3). Toxic if inhaled (H331). Avoid breathing mist, vapors or spray (P261).

SECTION 4 — FIRST AID MEASURES

Immediately call a POISON CENTER or physician (P310).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340). **If in eyes:** Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do so. Continue rinsing (P305+P351+P338). **If on skin (or hair):** Immediately remove all contaminated clothing. Rinse skin with water (P303+P361+P353). Wash contaminated clothing before reuse (P363). **If swallowed:** Rinse mouth. Do NOT induce vomiting (P301+P330+P331).

SECTION 5 — FIRE FIGHTING MEASURES

Noncombustible liquid.

When heated to decomposition, may emit toxic fumes.

In case of fire: Use a tri-class dry chemical fire extinguisher (P370+P378).

SECTION 6 — ACCIDENTAL RELEASE MEASURES

Remove all ignition sources and ventilate area. Contain the spill with sand or other inert absorbent material, neutralize with sodium bicarbonate or calcium hydroxide, and deposit in a sealed bag or container. See Sections 8 and 13 for further information.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #1. Store with acids, anhydrides and peracids. Store in an acid cabinet, away from any source of water; if an acid cabinet is not available, store in a Flinn Saf-Cube™.

Keep container tightly closed (P233). Keep cool (P235). Do not breathe mist or spray (P260). Use only in a hood or well-ventilated area (P271).

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Wear protective nitrile, neoprene or butyl rubber gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271).

Clear colorless liquid. Strong odor like vinegar.

pH: acidic

Avoid contact with strong oxidizers, especially chromic and nitric acids.

Shelf life: Indefinite, if stored properly.

Acute effects: Corrosive to body tissues and mucous membranes.
